



CORPORATE MATCHING GIFTS PROGRAM INFORMATION

The Corporate Matching Gift program makes it easy to double the impact of your charitable contribution. Eagle Land Services, Inc. will match your contribution, up to \$500 per person, each calendar year, to the designated charities listed below. You must be a current employee or independent contractor in good standing with Eagle Land Services, Inc. to be eligible.**

How does the program work?

1. Make a contribution in the form of a financial gift to one of the approved, qualified charitable organizations either online at the receiving organization's website, or, mail a check to them with the CMG form that is attached.
2. Print out the CMG form and complete **Section A**. Mail the form to the receiving organization's designated address listed below along with a copy of a printed, online contribution receipt or an actual check.
3. Eagle will verify that your contribution was received by the organization.
4. Eagle will pay the matching gift directly to the organization.
5. When the gift is paid, you will receive notification via email from matchinggifts@eaglelandservices.com
